Purpose

To promote historic preservation and beautification efforts in Sanford; to formulate regulations and policies; to promote those goals; and to make recommendations to the City Council concerning the creation of historic districts and landscape regulations.

Appointment Authority

The Commission shall consist of at least seven members appointed by the City Council to serve three-year staggered terms as outlined in the Unified Development Ordinance. The majority of members must have a special skill, background, or live in a potential district (planners, landscape architects, building architects, horticultural boards, lawyers, etc.).

Authority

To designate historic districts upon approval of the City Council; to receive gifts; to purchase property; to conduct inspections; to make recommendations; to sit as a Board of Review regarding changes in an historic district; to act as a broker; to preserve eligible properties; and may assist Lee County or Broadway in similar matters, etc. All funds for this board are accounted for and expended through the City Financial Services Department as an expense of the Downtown Revitalization Department.
